RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO: 10-TM-07

BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA THAT:

WHEREAS, this organization is a recognized Indian Organization as defined under the Indian Reorganization Act of 1934, as amended, and exercises rights of home rule and is responsible for the promotion of the economic, health and welfare of its members; and

WHEREAS, the Te-Moak Tribe is the parent Council for the communities of Elko, Battle Mountain, South Fork and Wells; and

WHEREAS, the Te-Moak Tribe has been notified by the Bureau of Indian Affairs (BIA), Western Regional Office, Division of Transportation that \$65,419.00 is available through the American Recovery and Reinvestment Act (ARRA) of 2009 for construction of the following two projects:

H64A03-BMIC Safety No. 1 (Patch Potholes & Scrub Seal BIA Route 1) - \$53,000.00
H64A04-ELIC Safety No. 1 (Patch Potholes & Scrub Seal BIA Route 101) - \$12,419.00

WHEREAS, the Te-Moak Tribe supports the goals and objectives set forth in the FY'2009 American Recovery and Reinvestment Act (ARRA) and the proposals submitted by the Elko Band and Battle Mountain Band; and

WHEREAS, the Te-Moak Tribe hereby supports the Elko Band Resolution #2010-EBC-06 on their submission of a grant proposal for their portion in the amount of \$12,419.00 of the American Recovery and Reinvestment Act (ARRA) funding; and

WHEREAS, the Te-Moak Tribe hereby supports the Battle Mountain Band Resolution #10-BM-11 on their submission of a grant proposal for their portion in the amount of \$53,000.00 of the American Recovery and Reinvestment Act (ARRA) funding; and

THEREFORE, BE IT RESOLVED, the Te-Moak Council does hereby support the Elko Band Council and Battle Mountain Band Council to utilize the American Recovery and Reinvestment Act (ARRA) funding and approves the BIA to distribute the funds herein to both entities.


BE IT FINALLY RESOLVED, that the Chairman of the Te-Moak Tribal Council is hereby authorized to execute and submit such documents as may be necessary to carry out the purpose of this Tribal Council Resolution.
